


**INTERNATIONAL TENDER NOTICE FOR IMPORT OF WHEAT

Tenders in sealed cover are invited from bonafide traders for supply of 1,00,000 (One hundred thousand) Metric Tons of Wheat. The particulars of tender are furnished below:

- a. Quantity : 1,00,000 (One hundred thousand) MT. (5% more or less at seller's option), **Minimum quantity to be offered is 30,000 (Thirty thousand) MT (60% for Chittagong port & 40% for mongla port).**
- b. Basis : 1,00,000 (One hundred thousand) MT. at Chittagong and Mongla on CIF Liner Out at both ends (Cost of the Cargo, Insurance and Freight including Stevedoring are on seller's account. Lighterage, if any, is also on seller's account). **Single price per MT is to be quoted in US\$ for both Chittagong Port and Mongla Port. Quantity must be supplied 60% for chittagong port & 40% for mongla port.**
- c. Mode of Payment : Through Letter of Credit (L/C).
- d. Quality & specification : (i) Test weight (minimum): 75 Kg/hl,  
 (ii) Damaged kernels (maximum): 4% (including maximum 0.2% heat damaged kernels),
