

- b. Basis : 1,00,000 (One hundred thousand) MT. at Chittagong and Mongla on CIF Liner Out at both ends (Cost of the Cargo, Insurance and Freight including Stevedoring are on seller's account. Lighterage, if any, is also on seller's account). **Single price per MT is to be quoted in US\$ for both Chittagong Port and Mongla Port. Quantity must be supplied 60% for chittagong port & 40% for mongla port.**
